
- *Maintain and review systems, relating to the Company's environmental aspects, to ensure compliance with all applicable legal and other requirements to which the Company subscribes*
- *Encourage employee involvement in environmental matters at all levels through participative action groups, communication, training and reporting of environmental performance*
- *Set, publish and regularly review environmental objectives to achieve a continual improvement in environmental performance. The environmental objectives and targets identified during the assessment of significant environmental aspects; by the SHE Forum and reviewed at the Management Review Meeting*
- *Design and procure the product, whilst considering environmental aspects, to facilitate methods for the manufacture, packaging, distribution and installation of products which minimise all forms of pollution*
- *Actively source materials from certified, well managed suppliers, carrying out appraisals of vendors to ensure full traceability of products to source*
- *Train employees who could influence environmental impacts into the correct emergency procedures as well as the appropriate methods for; handling and using materials; operating and maintaining plant and equipment*
- *Maintain and review systems to minimise waste through careful selection of raw materials; stock and process control; changes in operational procedures and the recycling and reclaiming of raw materials*
- *Promote among suppliers and customers an appreciation of environmental issues with respect to the business' principles and values*
- *Actively monitor the use of energy to identify areas for reduction*
- *Review new technologies and material developments to reduce the Company's environmental impact*
